

Studying in Australia

Australia is a country located in the southern hemisphere, and the sixth-largest country in the world.

A highly developed country, Australia is the world's 12th largest economy and has the world's fifth-highest per capita income.

Australia ranks highly in many international comparisons of national performance, such as quality of life, health, education, economic freedom, and the protection of civil liberties and political rights.

- In 2016, 500,189 international students were enrolled in education programs within Australia.¹
- In 2016, Australia was ranked 10th best university system in the world.²
- \cdot Five Australian cities are ranked in the top 30 best student cities in the world. $^{\rm 3}$
- 2.5 million international students are alumni of Australian institutions, making a difference around the world.⁴

Sydney

Sydney, the capital of New South Wales, is the most popular city globally for international students.

- Sydney is ranked the 4th best student city worldwide, according to the QS Best Student Cities 2016 rankings.⁵
- The Mercer 2016 Quality of Living Rankings rate Sydney as the Australian city with the best living standards, and 10th in the world.⁶
- NSW is home to more international students than any other state, with 186, 673 students enrolled in 2016⁷
- More than 35,000 of these students study within the City of Sydney. With a vibrant mix of cultures and events, we are one of the most multicultural communities in the country.⁸

A student visa allows you to work for up to 40 hours a fortnight after your course start date and for the duration of your visa. You can also work unlimited hours during nonteaching periods.

All kinds of part-time work may be available to you in Sydney. Finding a job that is relevant to your course may be more difficult as you will be competing against other domestic and international students. You will need to be well prepared to find a job, though we can offer advice and support as you need it.

Preparing for your career

Victoria University's (VU) partnership with the Education Centre of Australia (ECA) allows VU Sydney students access to opportunities for improving English language skills in preparation to enter the workforce.

ECA's Department of Recruitment and Professional Development (DRPD) can help you find a job and prepare for your career by offering the three programs detailed on the next page.

Professional internship program

ECA is proud to offer VU graduates a Volunteer Professional Internship Program. This exciting program is designed for graduates seeking work experience in Australia.

The advantages of an internship include:

- gaining hands-on experience in your chosen field
- being exposed to Australia's professional culture
- developing a professional network
- gaining an advantage for job applications (for example, employers are interested in experience as well as qualifications)
- increasing your employment prospects. Host companies often look to train interns for future employment if they are successful during their internship.




Graduate Recruitment Program

A free program offered by ECA to VU graduating students, the Graduate Recruitment Program, prepares students in their final semester for job interviews and the Australian workplace. The program offers students a unique opportunity to find employment in their chosen field, and includes on-campus interviews with prospective employers.

Activities include:

- interview preparation and employability training, including mock interviews
- professional development counselling

 individual and group learning,
 preparation and role play
- resume writing, cover letter development, job search techniques, and interview preparation and follow up
- an in-house placement service
- on-campus interviews with a range of prospective employers.

Australian education

How to get there

This campus is easy to reach from all areas of Sydney via public transport; including train, bus or light rail, with Town Hall Station less than a five-minute walk. Students may be eligible for an international student discount, making trips to campus, and adventures outside of the classroom, affordable and accessible.

Life in Sydney

Sydney, the capital of New South Wales, is a popular destination for international students, appearing fourth in the QS Best Student Cities 2016 rankings. A melting pot of cultures, cuisines and international events, Sydney prides itself on being a multicultural metropolis. Besides its culturally diverse reputation, Sydney is famed for its spectacular harbour and beaches; internationally renowned sights such as the Sydney Opera House and Sydney Harbour Bridge; world-class restaurants; and bustling nightlife. As a student at VU Sydney, you will never be short of things to see and do between classes.

Campus and facilities

VU Sydney is conveniently located in the heart of the city with many restaurants, cafés and shops within walking distance of the Campus. The iconic Sydney Harbour and State Library of New South Wales are also accessible by foot, while there are plenty of public transport options to get you beyond the city centre.

Our friendly support team will help you in all facets of student life, from orientation to graduation. The on-campus environment is safe, supportive and friendly, with shared computer rooms, a student lounge and resource centre meaning you can spend time between classes studying and socialising.

Throughout the year there are numerous events, including the world-famous Sydney to Hobart Yacht Race and the Sydney Royal Easter Show.

Cost of living

While Sydney may sometimes seem expensive, remember that you are living in one of the best cities in the world. Costs will vary by location, and by your lifestyle. With a student card, you will be eligible for concession prices to events, the cinema, museums and more.

As part of your visa application, the Australian Government requires international students to declare that you have access to funds or a stream of income which is sufficient to meet the costs of your studies and the associated living costs. You may be required by the Australian Government to provide evidence of these funds or income stream.

From July 2016 the amount for students is AUD 19,830 per year. Find out more at border.gov.au/Trav/Stud/More/Student-Visa-Living-Costs-and-Evidence-of-Funds

The Department of Immigration and Border Protection recommends budgeting A\$19,830 per year to cover the cost of a single student living away from home in Australia. As part of your visa application, you are required to declare that you have access to funds or a stream of income sufficient to meet your study and living costs. Arrival and orientation

As you embark on your once-in-a-lifetime journey, VU Sydney will be with you every step of the way. When you arrive in Sydney, our dedicated team of support staff will give you all the information you need to find your way around campus and the city. Whether it's catching a bus, finding your classroom, knowing where to eat or how to find somewhere to live, we are here to help.

Each semester we conduct mandatory orientation sessions one week before the start of classes for all new students, to help you adjust to Australian life and make new friends. As part of our orientation program, you will learn about the Campus and its facilities, meet your teachers and classmates, and enrol in your units of study.

Transport

There are a range of options for you to make your way around Sydney. There are trains at the airport when you arrive; ferries to enjoy the harbour; plenty of taxis, trains and buses; plus a quality bike network if you like to travel by bicycle.

Schooling for your children



earning

Learning Support

VU Sydney is delighted to offer all our students continued academic support during their studies. Our Learning Support Advisers can provide you a lot of assistance with your study and are dedicated to helping you achieve your academic goals. As qualified teachers they can help you get the best out of your learning and help you with difficulties you might have with assessments. Our Learning Support Advisers have qualifications in English language teaching so they can help you understand academic language in assessment topics and subject matter. Moreover, they understand that it is not always easy writing an assignment, even when you know what you want to say; talk to them and they can help you get the words out of your head and onto your screen (or paper).

Studying at university means you have to develop skills that you might already have, like writing an essay and knowing how to use references. Our Advisers can teach you these skills. Get a group of people together and make an appointment and they will hold a workshop where you can learn and practise.

Academic workshops

A suite of workshops are offered throughout the semester. At the beginning of each semester there is a focus on bringing you up to speed. These sessions will be advertised around the campus and via social media. The skills required for succeeding in an Australian university are developed. These workshops can really help you get settled and ready to take on the academic work ahead of you. The topics covered include;

- Referencing Skills
- Submitting Assessments
- Exam techniques
- Critical thinking

Academic tutors

Every semester the university chooses students who have achieved high marks and employs them as tutors. All students receive an email with the tutors listed and the units they can provide assistance with. Students do not pay for tutor services. Students can contact the tutor directly. Remember: this service is free of charge and can really help if you are having difficulty with a unit.

PASS (Peer Assisted Study Sessions)

PASS is a free academic assistance program that utilises peer-led group study to help students succeed. The sessions are facilitated by PASS Leaders, current students who have already successfully completed the unit. In 2017 VU Sydney will be offering PASS programs for selected units. These sessions are a great way to get a better understanding of content that is being taught in class. It also enables you to develop your communication and teamwork skills. They are a great place to enhance your learning and make long lasting friendships with other people in your course. Please contact our Learning Support Advisers. Students who participate in Peer Assisted Study Sessions tend to acquire better outcomes and better grades than students who do not. PASS has been highly successful in many universities around the world.



Course Advice

The academic team is on hand to offer you course advice while you are enrolled at VU Sydney. An academic coordinator can issue you a study plan that will map out your enrolment to course completion. The academic coordinators can help you with a range of inquiries including Recognition of Prior Learning, unit selection, course progression and accrediting organisations. To arrange an appointment with your specific coordinator, you can come and see us at reception on Level 3. It is recommended that every student meet with an academic coordinator in order to plan for your success.

One-on-one academic support

Our learning support team are available to meet with students one-on-one. An appointment is not always necessary, but it is a good idea to use the details provided and contact a Learning Support Adviser if you feel that you need some kind of assistance. You can find the Learning Support Advisers on Level 3 in the Learning Commons. They are there to help, so don't be shy. If you have any concerns about an assessment or content being covered in a unit, the Learning Support Advisers are waiting to assist.

Student feedback

Your feedback regarding your learning experience at VU Sydney is highly valued. In each trimester of study, Victoria University will contact you to provide feedback via the Student Evaluation of Teaching/Student Evaluation of Unit (SET/SEU) survey. The content of your feedback is confidential and all feedback is welcome. The information received in the SET/SEU survey means that Victoria University can track your overall satisfaction with your course and how it is delivered at VU Sydney. You can also provide feedback to **principal@vu.edu.au** regarding any aspect of your academic experience.

Settling in

It can take time to settle into a new course and new surroundings. If there is anything you need help with or do not know who to ask, you can talk to our Learning Support Advisers and they will do their best to find out who can help you. Importantly, if you have any problem at all, speak to one of them early before it becomes a big problem.



At VU Sydney, we can help you find a study pathway so you can earn the degree you aspire to.

Australian education system

Australia has one of the best education systems in the world, and is among the top three urban destinations for international students (QS Best Student Cities 2016). You can be assured that you have made a good, safe choice by coming to VU.

Bachelor degrees

To begin a bachelor (undergraduate) degree you usually need to have a secondary school qualification equivalent to an Australian Year 12 certificate. Find out if you meet the minimum academic (international qualification) requirements to be eligible to apply for this course by reviewing the academic entry requirements listed by country.

vu.edu.au/entry-international

Applicants must be aged 18 or over to be eligible to apply for a bachelor degree.

Graduate diplomas

To gain entry into a graduate diploma, you will need to have finished your relevant bachelor degree or a graduate certificate. Find out if you meet the minimum academic (international qualification) requirements to be eligible to apply for this course by reviewing the academic entry requirements listed by country.

Applicants must be aged 18 or over to be eligible to apply for a graduate diploma.

Masters degrees (coursework)

Academic requirements for masters degrees are an undergraduate degree comparable to an Australian bachelor degree or graduate diploma. Find out if you meet the minimum academic (international qualification) requirements to be eligible to apply for this course by reviewing the academic entry requirements listed by country.

vu.edu.au/entry-international

Applicants must be aged 18 or over to be eligible to apply for a master degreee.

Articulation and pathways

You could be eligible to receive credit (advanced standing) for previous study. Or, if you don't meet the requirements for the course you want, you may be able to commence your studies at a different level in a related field and progress to your course of choice. For example, successful completion of a diploma or advanced diploma with our partner, Zenith Business Academy, will enable you to gain entry into the second year of nominated VU degrees.

Assessment methods

Like every university, we assess our students and give them a result for each unit of study. Because we care about our students' progress, our assessment is continuous. We want to see you do well.

We assess by the following methods:

- tests
- exercises
- essays and assignments
- presentations
- practical reports
- participation in individual and group projects

examinations.

You can be sure that the work you do well will go towards your assessment and ultimate success.

Fees

Prior to commencing at VU, you will be required to pay a fee deposit and sign your International Student Written Agreement in order to accept your offer into a VU course. Indicative course fees will be detailed in your International Student Written Agreement. Subsequent tuition fees will be charged one semester at a time. You may need to buy equipment or specific clothing, or travel on public transport to undertake work placements for some courses, and those costs are not included in your course fees. Where possible, we recommend confirming these fees prior to enrolling in your course. Fees will vary according to your course and are subject to change. Note that annual price rises will be applied to both commencing (new) and continuing students.

Refund policy

If special or exceptional circumstances prevent you from continuing your studies, you may be eligible for a full or partial refund.

If you need to discontinue your course and seek a refund, you will need to supply documentary evidence in support of your application.

English language requirements

All VU courses require a particular level of English language proficiency to ensure that you will be successful in your studies.

Recognition of prior English language studies

If you have completed a qualification where English was the primary language of instruction, you may be eligible for an English language exemption. Check our Guide to English Language Requirements at the following link to find out if you qualify.

You will be credited for 8 units of study.

Business (Enterprise)

Code: VDBE | CRICOS: 093391K

The Diploma of Business (Enterprise) provides students with the opportunity to prepare for transition into university studies and further studies in the Bachelor of Business (BBNS) and/or for transition to the business workforce at entry level.

The diploma will give you a broad introduction to the industry and a range of skills relevant to working in the business sector, including foundation skills in:

- accounting
- management
- marketing
- economics
- communications
- information technology.

Upon successful completion of the Diploma of Business (Enterprise), you will be eligible to receive a guaranteed one year credit into the Bachelor of Business qualification at Victoria University (VU). If you decide to pursue an employment opportunity and not continue your tertiary studies you will be eligible to graduate with the Diploma and have acquired a range of skills relevant in the business world to commence a successful career.

Organisations employing business graduates

As a business professional, you could gain employment in private business or the public sector in a broad spectrum of fields including human resources, retail and marketing.

This course helps you develop the skills and knowledge in a range of Information Technology fields allowing you to progress your qualifications and career in IT.

This course has been specially designed for students who do not meet the entry requirements for the Bachelor of Information Technology. You will receive additional support, where you can build the literacy and numeracy skills needed for a career in IT, and prepare for the transition into university study. Prepare supporting documents

To apply for a course, you must prove that you meet the entry requirements by attaching the relevant documentation to your application. This may include:

- evidence of your English language proficiency
- certified copies of your academic transcripts and graduation certificates
- completed Background Information Checklist
- completed Advanced Standing forms (formerly known as Recognition of Prior Learning or RPL)
- other relevant documents such as letters from employers or schools, statement of purpose or research proposal.

Complete and application

You can submit an application online and attach supporting documents using our online international application and enquiry system. The system also allows you to:

- check your application status
- respond to admission officers' comments

• prepare to accept your offer.

If more information is required after you have submitted your application, you will receive an email from VU staff advising of a change of status in your application.

Accept your offer

If you have been given a conditional offer, you must meet all conditions before you can accept your offer.

Once you receive a full offer you need to:

- sign and return your International Student Written Agreement
- pay your course fee deposit
- pay your Overseas Student Health Cover.

If your visa application requires an electronic Confirmation of Enrolment (eCoE), Victoria University will send an eCoE to you after your International Student Written Agreement has been processed.

DON'T FORGET:

Allow enough time to apply for a student visa.

Organise your visa

Begin your visa application once you have obtained your eCoE.
